# LAKE OF THE PINES BOARD OF DIRECTOR MEETING April 13, 2019

President Dave Pohoda called the meeting to order at 10:00 a.m. There were 27 Association members present. Dave asked everyone to rise and face the flag and say the Pledge of Allegiance.

Roll Call was taken and all Board of Directors were present except Don Borle, Steve Andrews and Rick McCombe all were excused.

#### APPROVAL OF MINUTES -

1.) Motion by Geri Shaw, seconded by April Schmelter, to approve the March 9, 2019 Board Meeting minutes. Vote taken. **MOTION PASSED**.

#### **ANNOUNCEMENTS:**

1.) Dave Pohoda announced that next Sunday is Easter and the dump will be closed on Easter Sunday.

## **OFFICERS REPORTS:**

#### PRESIDENT: Dave Pohoda~

- 1.) Dave reminded everyone that the Board Meetings are run according to Robert's Rules as stated in our Covenants so we have to follow them. The Board of Directors are the ones elected to run the business of Lake of the Pines. When a motion is made, if it is something big the Board tries to make sure there is at least 2 months to allow members to give their input. ## SECRETARY AND CORRESPONDENCE: Vicki Brauner~

- 1.) Motion by Vicki Brauner, seconded by Geri Shaw, to accept the packet for the Annual Meeting. Vote taken. **MOTION PASSED.**
- Motion by Vicki Brauner, seconded by Geri Shaw, to cancel May 11th Board of Directors Meeting as the Annual Meeting is on the 25th of May. Vote taken. MOTION PASSED.

## TREASURER: Geri Shaw ~

- 1.) Motion by Geri Shaw, seconded by Rick Sieg, to pay the bills for the month of March in the amount of \$45,879.91 noting \$29,100 was for the lake. Vote taken. **MOTION PASSED.**
- 2.) Motion by Geri Shaw seconded by Dennis Woodward, to purchase a tape recorder to keep in the Office and a sign put on the wall that says this conversation may be recorded. People are coming in and yelling at the Office girls. The Office help follows what the Board tells them to do and they make no decisions on their own. There is no reason for people to yell at our employees. Vote taken. **MOTION PASSED.**
- 3.) Geri also reminded everyone that after April 1st late charges are \$25 per lot plus 12% per annum.

## **COMMITTEE REPORTS:**

#### EXECUTIVE: Dave Pohoda~

1.) Dave Pohoda reported there is a long waiting list for a dock on Pontoon Island. The Board has received complaints that there have been vacant docks for a long time. The Board had a workshop and came up with some new rules. On the docking agreement the Board added a part stating your dock will be forfeited for the following reasons~(1) maintenance assessment and docking fee not paid by April 1st, (2) subleasing or allowing someone else to use your dock for an extended period of time (3) if your dock is vacant for 2 consecutive years you will forfeit your dock.

## ARCHITECTURAL: Rick McCombe~ Absent. No report.

## ECOLOGY: Don Borle~ Absent. Dennis Woodward gave Don's report.

- 1.) We will be putting galerucella beetles that eat purple strife in our lake. They originate in Montana and are raised in the nature center in Kalamazoo. The cost is .40 per beetle and we will be spending \$500 buying 1,250 beetles. The beetles are put on pods. They are a native beetle and only eat the purple strife. The beetles will be put into the lake in July.
- 2.) Minnows will be put in the lake around the 1st of June. The minnows will be purchased from Johnson Elevator in Clare. The cost is \$160 for 10,000 minnows. There are 2,000 minnows per gallon.

## MAINTENANCE: Steve Andrews~ Absent. Dave Pohoda gave Steve's report.

1.) The docks will be going into the water in about 3 weeks. Some of the docks need repair. All the docks will also be sprayed with Thompson's Water Sealant.

## NOMINATING/BALLOTING: Rick Sieg~

1.) Rick reported the voting will be 9 am to 11 am on May 25th. Two people stepped up to fill the two vacant spots on the Board. The Annual Meeting will be at 1:00.

## PERSONNEL: Bob Eckardt~

1.) Motion by Bob Eckardt, seconded by Geri Shaw, to amend the motion made on December 8, 2018 to raise the salary cap for full time employees to \$17 per hour and part time employees to \$12 per hour. Vote taken. **MOTION PASSED.**

- 1.) Tim reminded everyone that there are still 22 to 25 memorial bricks still to install.

Geri stated that any member can go in the Office and say they are going to keep the pool open. That person has to let everyone into the pool, they also have to do the report for the Department of Health, they have to collect the money and pass out the pool bands.
