The milfoil will be treated in about one week. Hopefully we will stay within budget of \$30,000 this year. Next year will be a pretty big hit.
- 2.) Don reported the foresters are done cutting. So far we have gotten \$52,000 and there should be another \$9,000. Before the foresters leave there will be a walk through to make sure we are satisfied with the cleanup.
